Payment of Accounts

Payment should be made by the due dates according to one of the following methods:

1. Pay via **EFTPOS** machine – Credit Card or Savings Accounts
2. Pay by **phone** from your credit card to the School Office on 6318 7800
3. Payment by **B-Pay**. Biller code: (new code to be advised). Contact your financial institution via telephone or Internet banking to make this payment. **Refer to your statement for your reference number**
4. Payment by **Direct Debit**, this allows your account to be paid automatically to the school from a nominated bank account. Please complete the form on the bottom of your statement.

Overdue Fees

Where no arrangements have been made with the Principal or the Finance Officer, the School without notice, will seek recovery through its Debt Collection Agency. Parents and carers will be liable for any legal costs and commissions incurred through recovery of the debt.

Please note: School Fees are jointly and separately payable by parents. Both parents and carers are responsible for school fees unless there are custody orders that indicate otherwise.

Year 6 Camp

Parents and carers will be notified in advance of the cost prior to the camp.

Written notice of Withdrawal

If you wish to withdraw your child from the school you will need to give at least the equivalent of **one term's written notice (10 weeks)**, otherwise the full term fees will be requested to be paid. If you give written notice after 6 October 2024 then Term 1, 2025 fees will be charged.

Insurance – student personal accident/disability

The School's insurance covers students Personal Accident/Disability for 24 hours, seven days a week, details of which are available to parents through our website www.aranmorecps.wa.edu.au - link to CCI claims. Health Care Card Tuition Fee Discount Scheme

Parents and carers who are responsible for the payment of school fees and present a current means tested family Health Care Card or Pensioner Concession Card will be entitled to a significant discount on tuition fees for Kindergarten to Year 6.

The discounted **tuition fee** per student for 2024 is as follows:

\$300.00 per year	Kindergarten students
\$300.00 per year	Primary students (Pre Primary-Year 6)
\$ 90.00 Building levy	Kindergarten – Year 6

Discounted tuition fees do not cover additional charges such as camp, the compulsory building charge, Information Technology, Amenities and excursion costs.

To access the Health Care Card Tuition Fee Discount Scheme parents and carers will need to present a valid Health Care Card or Pensioner Concession Card and complete a simple form within two weeks of the beginning of school year. Holders of cards that are due to expire will need to show their new card for the discounts to continue.
